Agreement of future care for Abhigyan and Aishwarya

This agreement is to meet the decision set on the 28th of November 2011 of the County Committee for Child Welfare and Social Affairs in Rogaland, Norway and to make a settlement by the county court of Stavanger to ensure that the children Abhigyan and Aishwarya Bhattacharya can return to India to grow up with their paternal uncle as primary caretaker. The agreement sets out the responsibilities and obligations of both the biological parents and for the paternal uncle Arunabhas Bhattacharya. The agreement should be governed by the relevant laws of India as mentioned in note from the Embassy of India (Annexure I)

As parents of Abhigyan and Aishwarya we, Anurup Bhattacharya and Sagarika Chakraborty, agree that:

Our children Abhigyan Bhattacharya, born 12.10.08 (Holder of Indian passport number: H5712616) and Aishwarya Bhattacharya, born 06.12.10 (Holder of Indian passport number: J6681247), are placed in foster care and custody with their paternal uncle, Arunabhas Bhattacharya. He will be their foster parent and guardian, and they will live with him as long as they are minors.

Abhigyan is in need of medical treatment and necessary follow ups. The reputed Dr. Anjan Bhattacharya, who is a specialist in Emotional Behavioral Development has agreed to treat the boy at the Apollo Gleneagles Hospital, Kolkata. We will cover all expenses related to this necessary treatment.

As foster parent and guardian I, Arunabhas Bhattacharya, agree to:

Support and care for the children whose custody is being given to me and whose guardian I will be in terms of this instrument/agreement as members of my family and I will look after and promote, inter alia, their health and education. To promote the children's well being in respect of their physical, emotional, and cultural development. Contribute to the assessments of the children's educational needs. Actively encourage the children's knowledge and experience of their religious, cultural and linguistic background and ethnicity.

Ensure that the children are registered with a General Practitioner and that they receive appropriate health care which may include contact with General Practitioners, dentists, opticians and mental health specialists. Furthermore the information gathered by the Norwegian authorities will be made available to the relevant specialists in India.

We are entering into this agreement out of our free will and volition without any coercion or influence from anyone and we are capable of and competent to perform our duties as recorded herein.
